CONDITION OF SALES

INFORMATION ON THE PROCESSING OF PERSONAL DATA

Pursuant to and for the purposes of articles 13 and 14 of Regulation (EU) 2016/679 - General Data Protection Regulation (GDPR) - the General Regulation on the processing of data Oleificio Cisano S.r.l. declares that the personal data collected is processed exclusively for fulfilling the contractual performance requested and for sending the Customer/Purchaser information relating to the types of products purchased or on which the Customer/potential Customer has requested information. In the event that the conditions envisaged by current regulations regarding the collection of consent occur, the data collected may be used by the Data Controller for sending communications relating to special offers, gift packages and reserved shopping vouchers. The data will be entered in the order management system (Management Software) and in the customer management system (CRM) and processed in paper and electronic form only by the subjects authorized to process the data, following a specific written appointment conferred by the Data Controller. Oleificio Cisano takes great care about the privacy and confidentiality of data acquired from its customers and potential customers and adopts a "Privacy by Design" management system in order to protect this data thanks to the best hardware and software technologies, internal collection procedures, management, modification, rectification, treatment in general, including cancellation and thanks above all to the constant training of its employees and collaborators on the issues in question. It has drafted a Treatments Register, which is kept updated and has appointed a Data Protection Officer who can be contacted by writing to info@museum.it. The data controller is Oleificio Cisano S.r.l. with headquarters in Via Peschiera 54, Fraz. Cisano – 37011 Bardolino (VR) in the person of the Legal Representative Mr. Turri Flavio. The provision of data by the Customer/ Purchaser must be considered necessary for the performance of the requested services. In the event that the Customer/Purchaser/Potential Customer does not consent to the processing of data, it will not be possible to fulfill the contractual obligations and therefore collect and process the data according to the law. Personal data will not be communicated and / or transferred to third parties except for that data that may be communicated, for the temporary use necessary to fulfill the obligations envisaged, to the companies responsible for the shipment and delivery of the ordered products, as well as to others subjects who will handle specific phases that are part of the sales process, with the exclusion of any other natural or legal person that is not necessary to fulfill the request of the Customer/Purchaser himself. The Customer/Purchaser can exercise his rights at any time as expressed in articles 15, 16, 17, 18, 19, 20, 21, 22 of the EU Regulation 2016/679, addressing the Data Controller, by sending an email to info@museum.it. The Customer/Purchaser has the right, at any time, to ask the Data Controller for access to his personal data, the rectification, the deletion of the same, the limitation of processing. In addition, he has the right to object, at any time, to the processing of his data (including automated processing, e.g. profiling), as well as the portability of his data. Without prejudice to any other administrative and judicial appeal, the Customer / Purchaser, if he considers that the processing of data concerning him violates the provisions of Regulation (EU) 2016/679, pursuant to art. 15 letter f) of the aforementioned EU Reg. 2016/679, has the right to complain to the Guarantor for the Protection of Personal Data and, with reference to art. 6 paragraph 1, letter a) (consent) and art. 9, paragraph 2, letter a) (consent for single purpose particular data), where applicable, has the right to revoke the consent given at any time. In the case of a data portability request, the Data Controller will provide the Customer/Purchaser with the personal data concerning him/her in a structured format, commonly used and readable, by an automatic device, without prejudice to paragraphs 3 and 4 of the art. 20 of the EU Reg. 2016/679. Additional data relating to the methods of data processing, company policies and confidentiality rules adopted by the company are available in the Privacy section of the official website www.museum.it. The owner reserves the right to modify, update, add or remove parts of this privacy statement at its discretion and at any time. In order to facilitate this verification, the information will contain the indication of the updated date.

HOW TO ORDER CHRISTMAS PACKAGES

By sending an email to ordini@museum.it indicating the article code and the number of packages desired, YOU CANNOT ORDER AND PAY ONLINE. Subsequently we will send the customer an order confirmation where the transport costs and payment methods will be indicated which can be made by bank transfer or Paypal, the customer can, without obligation, confirm the quote. The packages can be added to orders placed online up to a maximum of four pieces, when this limit is exceeded, even if there are promotions on transport costs, we will reserve the right to calculate a fee based on weight and volume, such cost will be indicated in the order confirmation sent to the customer under the item "transport costs fee".

WARRANTY

Oleificio Cisano srl guarantees that the contract products are compliant with food laws. It also recognizes the legal guarantee of conformity on goods purchased in accordance with Articles 128-135 of the Consumer Code (Legislative Decree no. 206/2005), in the case where the buyer is a consumer and in accordance with Art. 1490 e ss. c.c. in the case of professionals.

CONDITIONS OF SALE AND DELIVERY

The given prices are inclusive of VAT. Goods available while stocks last. The products will be delivered by our trusted couriers. Delivery will be made in the shortest time possible and in any event within thirty days from the date of conclusion of the contract. The customer, upon receipt of the goods, must check that the number of packages coincide with the number on the consignment note and the goods are not damaged. The goods will then be shipped to the client once the payment has been received.

NEW OSS SCHEME (ONE STOP SHOP)

The OSS (One stop shop) scheme is the new arrangement for distance sales made to end consumers resident in the European Union (subjects without a VAT number). CUSTOMIZING PACKAGES

On request we can make changes to packaging. The changes must be previously agreed assessing the feasibility. All packages were codified and entered in a special software program that allows us to serve our customers in a short time.

IMPORTANT INFORMATION: We are not allowed to export alcoholic products such as wine, grappa or liquors. In regards to food products such as pickles and oils, the price refers to the weight of the drained product.

VAT AND VALIDITY OF CATALOGUE

The catalogue prices are shown including and excluding VAT. Catalogue valid until: 31.12.2026.

Invoices must be requested at time of ordering indicating your VAT number.

WITHDRAWAL

The buyer has the right to withdraw, without needing to give any reasons and without penalty, within 14 days from the date of delivery of the goods. “Delivery” means the time when the buyer or a third party other than the carrier and indicated by the buyer acquires physical possession of the goods. After that period, the withdrawal period has expired. To exercise the right of withdrawal, the buyer is obliged to inform us (at the headquarters of Oleificio Cisano srl Via Peschiera 54 - 37011 Cisano VR - Tel: 045-6229047 - Fax: 045-6229024 - E-mail: info@museum.it) of their decision to terminate this contract by an unequivocal statement (eg a letter sent by post, fax or email). To this end they may use the attached model withdrawal form, but it is not obligatory. In order to comply with the withdrawal period it is sufficient that the buyer sends the communication concerning the exercise of the right of withdrawal before the expiry of the withdrawal period.

EFFECTS OF WITHDRAWAL

If the buyer withdraws from this contract he will be refunded all payments made on our behalf, including the cost of delivery (except for the additional costs resulting from a choice of delivery type other than the least expensive type of standard delivery offered by us), without undue delay and in any case not later than 14 days from the day we are informed of your decision to withdraw from this contract. Such refunds will be made using the same method of payment used by the purchaser for the initial transaction, unless the buyer has expressly agreed otherwise; in any case they will not incur any fees as a result of such refund (refund may be suspended until receipt of the goods or until proof is given by the consumer of having sent back the goods, whichever is earlier). In any case, in the event of exercise of the right of withdrawal, the purchaser is asked to return the goods in the same packaging or equivalent packaging to the headquarters of Oleificio Cisano srl (Via Peschiera 54 -37011 Cisano VR) without undue delay and in any event within 14 days from the day he announced to us his withdrawal from this contract. The deadline is met if the buyer sends back the goods before the expiry of the period of 14 days. The direct cost of returning the goods will be borne by the purchaser. The buyer is responsible for the diminished value of the goods resulting from the handling other than what is necessary to establish the nature, characteristics and function of the goods.
